Note 1: CSOI (Civil Service Officers Institute) membership as mentioned as at (d) is available to the serving / retired officers of the Govt. of West Bengal and Govt. of India (other than PSUs / Boards / Institutions / Universities / Parastatals and the like bodies) drawing / drew pay atleast in the Pay Level 21 under WBS (ROPA) Rules 2019 and Pay Level 13 under 7th CPC respectively corresponding to erstwhile Grade Pay Rs. 8700/- and above and also to the serving / retired Hon'ble Judges High Courts and Supreme Court.

Note 2: Family membership plan to play golf as at (f) above is available to maximum (four) members of a particular family subject to production of proof of family relationship among the members and no member of this plan can be replaced by any means.

The term 'family' appearing in Note 1 & 2 means spouse and dependent children.

Note 3: School membership plan to play golf as at (g) above is offered to schools in groups @10 (ten) students of a particular school per group. A teacher from the respective school must accompany the students to golf course and shall remain present during entire duration of the training. The school shall be responsible for arranging transportation for safety and security of the students.

2. The Active members of the New Town Business Club will be eligible for 20% concession on the prescribed rates for the below mentioned categories of membership plan subject to verification of their active membership with the New Town Business Club.

- a. Annual membership for adults
- b. Annual membership for junior
- c. Monthly training
- d. Monthly course training / Advance training
- e. Annual Family Membership

3. If an existing member belonging to para 1(a) & 1(b) refers someone for annual membership enrollment under para 1(a) or 1(b), the referee will be entitled to play one additional month at free of cost after completion of his annual membership.

4. A member possessing annual membership plan is required to renew his membership within one month of expiry of existing term, after which the membership will be cancelled.
