- ii) Participants should have experience of supply of catering / supply of food article.
- iii) Participants should have current Trade License in Decorating & Even Management from NKDA.
- iv) Should have PAN Card, Currant P. Tax Challan, GST with current return receipt, Income Tax Return Copy.
- v) List of machineries / vehicles owned or hired.
- vi) Participants must be financially sound.
- viii) Intending bidder should not be black listed from any Organization / Govt. Organization during las 05 (five) years.

B) Scope of Work: -

- i) Supply of D. G. Back up and necessary cabling.
- ii) Supply of chair and tables in the Eco Urban Village.
- iii) Supply of materials for erection of small stalls over a layer of carpet on the floor.
- iv) Supply of buffet table and chair for any programme.

- v) Supply and erection of gates, stalls, outside the Eco Urban Village block but within or in front of the Eco Urban Village Premises.
- vi) Placement of any banners and stand within the in the premises.
- vii) Provision for extra lighting outside the Eco Urban Village with D. G. set arrangements if required.
