Bidders who are not empanelled vide Notification No. No. 190-F(Y) dated 19/01/2022 of Finance Department, Govt. of West Bengal need not apply, if applied, their bid will not be considered for Technical Qualification and their financial bid shall not be considered.

3. Project Background

The Hon'ble Division Bench of Calcutta High Court passed an order on 13.09.2013 regarding

shifting/relocation of Esplanade Bus Terminus. A high-level meeting in presence of Principal Secretary/Transport Department, Principal Secretary/U.D. Department & Chairman, WBHIDCO, representatives from CSTC, WBSTC, WBTIDC, KMDA & WBHIDCO was held on 12.07.2013 had decided to earmark a plot of land in New Town, Kolkata for development of a Bus Terminus-cum-Commercial Complex in New Town, Kolkata.

The West Bengal Housing Infrastructure Development Corporation Limited (WBHIDCO) was entrusted with the responsibility to implement the Project of construction of a (B+G+VIII) storied International, Intra-State, Inter-State & Inter-City State of the Art Bus Terminus cum Commercial/Business Complex in New Town, Kolkata at Plot No. IID/39 (Premises No. 54-0676) in AA-IID, New Town, Kolkata on PPP model. Following is the detail of the plot selected for the project:-

4. Brief description of Scope of Work:

Towards the north side of the plot, the Bus Terminus cum commercial complex building will be constructed with parking facility for 100 buses and 10 arrival & departure bays. The plot would also comprise of a two-storied service building, with space for bus break-down area, washing area, two fuel filling stations, rainwater collection tank area, sewage treatment plant area, electrical sub-station area and requisite numbers of open car parking space on the south-east side of the plot for commuters and for business / commercial building. Separate arrival and departure halls will be provided on the ground and first floors of the building, to make available the facilities similar to that of any Airport. An approach flyover to reach the entry gate of the departure hall at the first-floor level will be constructed. The abutting street No. 676 along with its intersection with Rajarhat Road will be re-designed to accommodate the parking facility for taxis, e-rickshaws etc. along with smooth movement of vehicles, including buses along street No. 676.

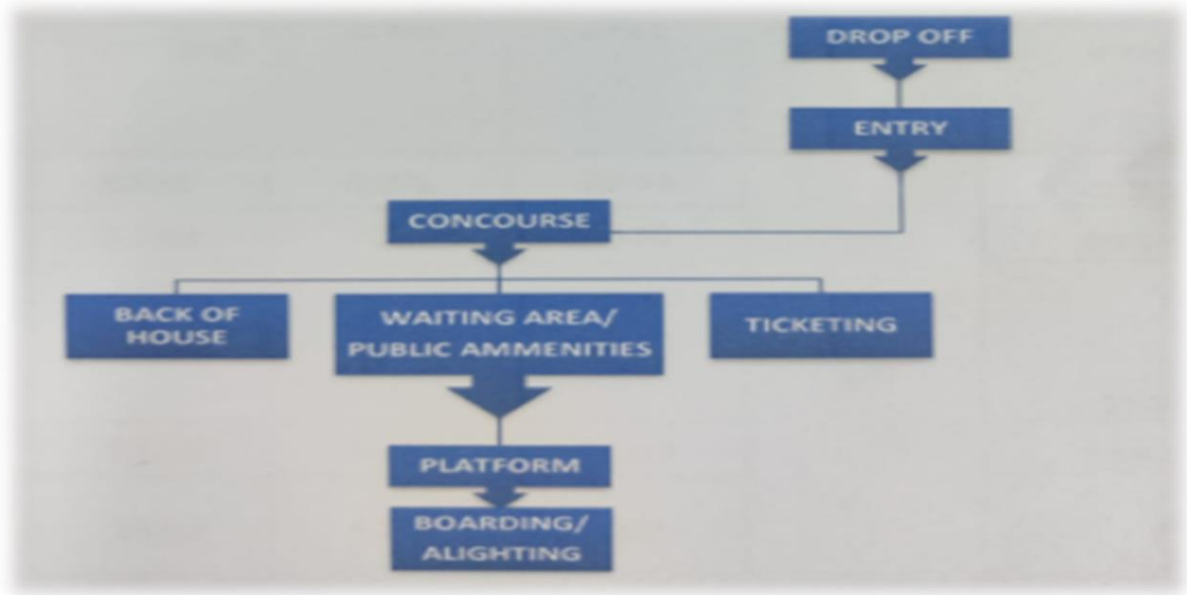


Figure: Terminus Hierarchy Planning

- Terminus from Basement to 2nd Floor and Commercial Development from 3rd Floor to 8th Floor).
- Land will remain under the ownership of WBHIDCO.
- The Miscellaneous cost will include the following:

- The project will be based on the Public-Private-Partnership (PPP) model. The WBHIDCO will provide the land to the PPP Developer but will not contribute any Fund. The PPP Developer will arrange the required funds for the development and execute the ISBT project. The Developer will hand over the Ground+1st + 2nd floors to WBHIDCO and common service areas, common service facilities, parking space etc. The rest of the built-up area may remain in possession of the PPP Developer for commercial purposes.
- Apart from the construction of the B+G+VIII storied building, an approach flyover to reach the entry gate of the departure hall at the 1st floor level to be constructed starting from Street No. 676 and again it will meet at Street No. 676 going round the Terminus building. The abutting Street No. 676 along

10.1. The selected bidder / firm will need to do a complete review of the existing documents (Good Construction Drawings, Detailed Estimate) related to the ISBT project. The information provided will need to be revalidated and confirmed.

mechanism of onboarding them for executing the construction and maintenance of the Inter State Bus Terminus and the Commercial Complex.

10.4. The clauses will need to be defined in such a manner that WBHIDCO's interests are protected. The main objective of developing a bus terminus will need to be achieved. The PPP Developer should neither be able to abort the project midway nor they can transfer the work to any third party.

10.5. The financial viability of the project will need to be confirmed in the DPR and accordingly the number of floors to be used by WBHIDCO beyond Ground Floor +1st Floor+2nd Floor and other common areas to recover the land cost or the premium to be charged to the PPP Developer may be suggested.

10.6. A strict timeline for the completion of the project will need to be defined. Service Level Agreements on the project execution and penalty clauses will need to be defined.

10.7. The use of the common service area, utility area between WBHIDCO and the PPP Developer will need to be clearly stated including how the individual parties may have access to these areas without obstruction of the other party.

10.8. Full specifications of the constructed area along with the materials, components to be used by the PPP Developer will need to be defined.

10.9. It is to be ensured that the commercial portion's operation cannot be started before the operation start of the bus terminus.

10.10. The regular operation & maintenance mechanism for a period of at least 5 years will need to be defined.

10.11. Evaluate if the PPP Developer will be allowed to form a consortium and the pre-qualification and technical eligibility criteria of the bidders.

11. Bid Submission

11.1 Only the bids received within the stipulated time will be evaluated. All bids will need to be submitted in English and the value quoted in Indian Rupees (INR), inclusive of GST & all other taxes, Cess as applicable.

11.2 All intending Bidders have to deposit Earnest Money Deposit (EMD) Rs. 25,000/-. Deposit of such EMD and uploading of the same online.

11.3 Bidders should take utmost care to ensure that the EMD and the proof of deposit of EMD to be uploaded. EMD deposited elsewhere will not be considered for participation in this e-tender. No interest will be payable on the EMD.

11.4 EMD of the unsuccessful bidders will be returned by WBHIDCO Ltd. after completion of the bidding process. The EMD of the Successful Bidder shall be automatically retained and will be converted to Security Deposit for the selected bidder.
