- ii) The selected tenderer will have to enter into an agreement with WBHIDCO within 07(seven) days from the date of issuing Work Order, the cost of which will have to be borne by the selected Tenderer.
- iii) Any tender containing overwriting is liable to be rejected. All corrections are to be attested under the dated signature of the Tenderer without which the tender may be considered informal.
- iv) No conditional tender shall be accepted.
- v) A prospective Tenderer requiring any clarification about the EOI document and the scope of work may contact the undersigned through e-mail/ letter before the Pre-Bid Meeting. After the Pre-Bid Meeting, no request for any clarification in this regard will be entertained.

- xiii) Facility Manager cum Supervisor will report to the authority of HIDCO on day to day basis and will be on duty 24 X 7. They will be the POC of the Guest & liaise between the authority and the Guest. They will also POC to supporting staffs. They will take care of day to day work as and when require by the authority.
- xiv) Facility Manager cum Supervisor while on duty, may connect to the authority with their own mobile phone and no mobile charges will be borne by the WBHIDCO authority.
- xv) Every fortnightly monitoring staffs by the officials of the agency in Snehodiya.
- xvi) Intending bidders should provide the rate against each type of man power supply on Man Days of Duty hours basis along with all statutory fees including bonus, dresses, P.F, ESI, if any etc.
