## KK. General guidance for e-Quotation:

Instructions / Guidelines for electronic submission of the Quotations have been annexed for assisting the contractors to participate in e-Quotationing.

#### a. Registration of Contractor:

Any contractor willing to take part in the process of e-Quotationing will have to be enrolled & registered with the Government e-Procurement System, through logging on to <a href="https://eQuotation.wb.nic.in">https://eQuotation.wb.nic.in</a> (the web portal of WBHIDCO the contractor is to click on the link for e-Quotationing site as given on the web portal.

- b. Digital Signature certificate (DSC):
  - Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of Quotations from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount. Details are available at the Web Site stated in Clause A.1. above. DSC is given as a USB e-Token.
- c. The contractor can search & download N.I.Q. & Quotation Document(s) electronically from computer once he logs on to the website mentioned in Clause A.1. using the Digital Signature Certificate. This is the only mode of collection of Bidding documentst.
- d. Participation in more than one work:

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job all his applications will be rejected for that job.
