- ❖ The successful supplier/bidder shall have to deposit a Security Deposit of Rs. 10,000.00 (Rupees ten Thousand) only in favour of WB HIDCO Ltd. in the form of an Account Payee Demand Draft / Fixed Deposit receipt from a Commercial Bank. Security deposit to be refunded to the party by WB HIDCO LTD., after completion of the contract period. No interest will be paid on security deposit by WB HIDCO Ltd. to the party during retention of the security deposit.

- ❖ In case of more then 100% hike in rate of supplies, a fresh negotiation of rates may be addressed by the supplier and the purchase committee.

❖ Payment terms and condition 30 days cycle.


