Joint Ventures : In case of a joint venture firm, the agreement will be signed by the lead partner only and the lead partner will be responsible for compliance of all contract provisions. Retention money towards performance Security amounting to 10% (ten percent) of the value of the work shall be deducted from the running account bill of the tenderer as per prevailing order. No interest will be paid on Security Deposit.

Agencies shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility.
