Joint Ventures : In case of a joint venture firm, the agreement will be signed by the lead partner only and the lead partner will be responsible for compliance of all contract provisions. A joint venture agreement of the partners of the joint venture firm and power of attorney in favour of lead partner to be submitted on time with tender documents and original to be shown at office.

Retention money towards performance Security amounting to 10% (ten percent) of the value of the work shall be deducted from the running account bill of the tenderer as per prevailing order. No interest will be paid on Security Deposit.

Agencies shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility.

All materials required for the proposed work shall be of specified grade in conformity with relevant code of practice (latest revision) accordingly and shall be procured and supplied by the agency at their own cost including all taxes. There shall be no provision of Arbitration.
