If found to have applied severally in a single work or more than a single work of that particular NIeT, all his applications will be rejected for that work / that NIeT without assigning any reason hereof.
- xii) **ELECTRICAL WORKS**: The contractor should have valid Electrical Contractor's license issued by the Licensing Board, Govt. of West Bengal / Director of Electricity of the concerned State Government.
- a) For Electrical items, the bidders must have valid Electrical Contractors' License with full time engagement of an Electrical Supervisor holding Supervisor Competency or equivalent 'National Supervisors' certificate of competency (scan copy of valid "Electrical Contractors License," "Supervisors' Certificate of Competency" and authentic Notarized documents regarding engagement of Electrical Supervisor as submitted to the licensing board, "Govt. of West Bengal" require in non-statutory documents).
- xiv) b) Electrical Working person should have workman permit.
- xv) The prospective Bidder must have an employee having Degree or Diploma in Electrical Engineering even he himself may be a Degree/Diploma holder in Electrical Engineering.
- 8. Running payment for work may be made to the executing agency as per availability of fund. The executing agency may not get a running payment unless the gross amount of running account bill is 10 (Ten) Crore. Provisions in Clause(s) 7, 8 & 9 contained in Tender Form No.2911(ii) so far as they relate to quantum and frequency of payment are to be treated as superseded.
- Adjustment of Price or Escalation of Price on any ground and consequent cost overrun shall not be permitted under any circumstances vide Notification No. 23-CRC/2M-61/2008 dated 13/03/2009 and No. 38-CRC/2M-61/2008 dated 20/04/2009. The bidders shall quote their rate accordingly.
- 10. Mobilization Advance: No mobilization Advance shall be allowed.
- 11. Security deposit:

Retention Money towards Performance Security (Security Deposit) amounting to 10% of the value of work done out of which 2% will be in the form of Earnest Money Deposit and rest 8% shall be deducted from the running account bills and final bill of the tenderer as per prevailing order/ norms of WBHIDCO LTD. No interest will be paid on Security Deposit. The amount of Security Deposite will be retained up to the end of Defect Liability Peirod (DLP) / Security Period. However, Security money may be released after completion of the work/ finalization of Final Bill against submission of Bank Guarantee for the same amount and getting confirmation from the issuing bank.

- 12. The Agency shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility. However, WBHIDCO LTD may provide surplus land, if available, for labour hutment, batching plant, etc. on hire basis @ Rs. 1,00,000.00 (Rupees One Lakh) only per Acre per month if required by the Agnecy.
- 13. All materials required for the proposed work shall be of specified grade inconformity with relevant code of practice (latest revision) accordingly and shall be procured and supplied by the agency at their own cost including all taxes. If required by the Engineer-in-Charge, further testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their (Contractor) own cost.
- 14. Constructional Labour Welfare CESS as per provisions of "The Building and Other Construction Workers Welfare Cess Act, 1996 and Rules thereunder @ 1% (one percent) of cost of construction (Gross bill value) will be deducted from every Bill of the selected agency.
- 15. Arbitration: There shall be no provision for Arbitration Clause.
- 16. **Bid Validity Period**: The Bid shall remain valid for a period not less than 120 (One Hundred and Twenty) days from the last date of submission of Financial Bid / Sealed Bid. If the bidder withdraws the Bid during the validity period of Bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.

In case of any inadvertent typographical mistake found in the specified schedule of rates / BOQ/ Unit or elsewhere, the same will be treated to be so corrected as to conform with the relevant schedule of rates based on which the technically sanctioned estimate was prepared. 19. **Defect Liability Period (DLP) & Refund of Security Deposit:** The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a **period of 1 (One) year** from the date of successful completion of the work to the entire satisfaction of the Engineer-in-Charge. If any defect / damage is found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the Contractor will be imposed by the Department as deemed fit. The Contractor may quote his rate considering the above aspect.

Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the work as mentioned above for 1 (One) year from the date of completion of the work. Provisions in Clause 17 contained in WBHIDCO Tender Form No. 2911 so far as they relate to DLP and refund of security deposit is to be treated as superseded.

- 20. The guarantee/ warranty certificate to be issued by the dealers/ manufactureres for different materials/ item of works/ fitting & fixtures to be transferred to the Engineer-In-Charge before release of Final Bill/ Security Deposite as the case may be.
- 21. Site of work and necessary drawings may be handed over to the agency phase wise. No claim in this regards will be entertained.
- 22. The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all

informations that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting
Tender, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense. The Tender Inviting Authority
may depute his representative for indentification of the work site if desired by the intending Bidders.

- 23. The intending Bidders shall clearly understand that whatever may be the out come of the present invitation of Bids, no cost of Bidding shall be reimbursable by WBHIDCO LTD. The tender accepting authority (TIA) of WBHIDCO Ltd. reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.
- 24. Refund of EMD of unsuccessful bidders: The Initial Earnest Money of all the unsuccessful tenderers deposited online through e-procurement portal of Government of West Bengal Website http://wbtenders.gov.in with the tender will be refunded accordingly to the order of Finance Department of Government of Wesrt Bengal vide No. 3975-F(Y) of 28th July, 2016.
- 25. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' stated in Section 'A' before tendering the Bid.
- 26. Conditional / Incomplete tender will not be accepted under any circumstances.
- 27. The intending tenderers are required to quote the rate online.
- 28. The Contractor shall have to comply with the provisions of (a) The Contract Labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) Minimum Wages Act. 1948 of the notification thereof or any other laws relating there to and the rules made and order issued there under from time to time.
- 29. Guiding Schedule of Rates: Rates of Civil Works have been taken from P.W.D. (W.B.) Schedule of Rates Volume-I (Building Works effective from 01.11.2017); Volume-III (Sanitary & Plumbing Works effective from 01.11.2017), Volume-III (Road & Bridge Works effective from 30.08.2018) along with upto date corrigenda & addenda applicable for Kolkata, 24 Parganas (North & South) Areas and Delhi Schedule of Rates (CPWD) 2018 and Analysed Rates from market price also considered for a few item of works. Rates of Electrical Works and other works related to Electrical/ Electronis/ Fire Fighting/ HAVC/ ELV etc have been taken from P. W. D. Schedule of Rates for Electrical Works (Volume-I) effective from November, 2017, Delhi Schedule of Rates, 2018 and Market Rate Analysis for a few item of works.
- 30. During scrutiny, if it comes to the notice of the Tender Inviting Authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
- 31. The Tender Inviting Authority/ General Manager (Engg)-I, WBHIDCO LTD reserves the right to cancel the NIeT due to unavoidable circumstances and no claim in this respect will be entertained.
- 32. The Bid Evaluation Committee will do the technical and financial evaluation of the bidders for different type of works and make recommendation to the tender accepting authority. The bidders shall have to meet all the minimum criteria regarding:

- b) Technical Capability comprising of Technical personnel & equipment capability.
- c) Experience / Credential.

- 37. Additional Performance Security: As per W. B. Finance Department G.O. No. 4608-F(Y) dated 18/07/2018, an Additional Performance Security @10% of the tendered amount shall have to be deposited by the successful Bidder (L1 Bidder) if the accepted Bid value is 80% or less of the estimated amount put to tender.

The Additional Performace Security shall have to be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the successful Bidder fails to submit the Additional Performance Security within seven days from the issuance of Letter of Acceptance or as per time schedule mentioned in Letter of Acceptance, his Earnest Money may be forfeited to WBHIDCO and other necessary actions as per NIeT like blacklisting of the Contractor, etc. may be taken. INSTRUCTION TO BIDDERS

General guidance for e-Tendering:

Instructions / Guidelines for electronic submission of the tenders have been annexed for assisting the contractors to participate in e-Tendering.

1. Registration of Tenderer/ Contractor:

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement System, through logging on to https://etender.wb.nic.in (the web portal of WBHIDCO the contractor is to click on the link for e-Tendering site as given on the web portal).

2. Digital Signature certificate (DSC):

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount. Details are available at the Web Site stated in Clause A.1. above. DSC is given as a USB e-Token.

3. The contractor can search & download N.I.T. & Tender Document(s) electronically from computer once he logs on to the website mentioned in Clause A.1. using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

4. Participation in more than one work:

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job all his applications will be rejected for that job.

5. Submission of Tenders:
