Joint Ventures : In case of a joint venture firm, the agreement will be signed by the lead partner only and the lead partner will be responsible for compliance of all contract provisions. Adjustment of price in respect of construction materials shall not be applicable. The bidders shall quote their rate accordingly.

No mobilization advance and secured advance will be allowed.

Security Deposit:

Retention money towards performance Security amounting to 10% (ten percent) of the value of the work shall be deducted from the running account bill of the tenderer as per prevailing order. No interest will be paid on Security Deposit.

Agencies shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility.

All materials required for the proposed work shall be of specified grade in conformity with relevant code of practice (latest revision) accordingly and shall be procured and supplied by the agency at their own cost including all taxes. If required by the Engineer-in-Charge, further testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their own cost.

Construction Labour Welfare CESS @ 1% (one percent) of cost of construction will be deducted from every Bill of the selected agency.

There shall be no provision of Arbitration.

Details are available at the Web Site stated in Clause A.1. above. DSC is given as a USB-Token.

- iv. **Participation in more than one work:**
