**NB: - (i) Intending Tenderer will not have to pay the cost of tender documents for the purpose of participating in e-tendering,** but the successful L<sub>1</sub> (Lowest) Bidder will have to pay the cost of tender documents of 03 (three) sets @ price mentioned in the list (Sl. No.-4) of scheme of e-NIT during purchase of tender documents for execution of agreement as per notification no. 199-CRC/2M-10/2012 dated 21/12/2012.

**Earnest Money Deposit / Bid Security will have to be submitted as soft copy (Scanned copies of the Originals) along with the tender for instruments (Bank Draft) and in case of deposit of money it should compulsorily be deposited on line by the bidders. The L<sub>1</sub> bidder will submit the hard copy of documents to the tender inviting authority with his acceptance letter of the LOI within specified time as mentioned in the letter of acceptance. Failure to submit the hard copy with the acceptance letter within the time period prescribed for the purpose may be construed as an attempt to disturb the tendering process and will be dealt with according to legal provision including black listing of the bidder.**

- iii) The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 05 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. **(A declaration in this respect through affidavit has to be furnished in prescribed format by the prospective bidders without which the Technical Bid shall be treated as non-responsive.)**

- iv) In case of Proprietorship, Partnership Firms and Company, Tax Audit Report in 3CD Form are to be furnished along with the Balance Sheet and Profit and Loss Account, and all the documents along with schedules forming the part of Balance Sheet and Profit & Loss Account for the last 03 (three) years should be submitted in favour of applicant. **8) Joint Ventures will not be allowed.**

Propose bidder shall be allowed to participate in a particular job either in the capacity of individual or as a partner of a firm. If found to have apply severally in a single job all his application will be rejected for the job, without assigning any reason thereof.

**9) Payment of Bill**

Running payment for work may be made to the executing agency as per availability of fund. The executing agency may not get a running payment unless the gross amount of running bill is Rs.20.00 (twenty) Lakh or 33% of the tendered amount whichever less is. Provisions in Clause(s) 7, 8 & 9 contained in WB HIDCO Form so far as they relate to quantum and frequencies of payment are to be treated as superseded.

Agency will have to submit detailed measurement in a measurement book or in booklet form. Mode of measurement as per PWD norms. Site measurement will be taken by the agency along with the site supervisor of the Employer, duly signed by the authorized representative of the agency, to be submitted along with bill for its scrutiny and checking, both financially & technically, for processing payment.

**For (a) Procurement of goods and services and (b) Works related contract involving supply of goods and services by contractor. Tax Invoice (S) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provision of GST Act 2017.**

10) **Security Deposit:**

Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the work as mentioned above for 01 (one) year from the date of completion of the work. Provision in Clause No.-17 of WB HIDCO Form shall be treated as superseded.

Retention money towards performance Security amounting to 10% (ten percent) of the value of the work shall be deducted from the running account bill of the tenderer as per prevailing order. Out of which 2% in the form of earnest money and rest 8% to be deducted from successive running account bill of the tenderer as per prevailing provision. No Interest will be paid of Security Deposit.

**Additional Performance Security**

**Additional Performance Security @10% of the tendered amount shall be obtained from the successful bidder if the accepted bid value is 80% or less of the Estimate put to tender. The Additional Performance Security shall be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his Earnest Money will be forfeited and other necessary actions as per NIT like blacklisting of the contractor, etc. may be taken. The Bank Guarantee shall have to be valid upto end of the Contract Period and shall be renewed accordingly, if required. The Bank Guarantee shall be returned immediately on successful completion of the Contract. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor. Necessary provisions regarding deduction of security deposit from the progressive bills of the contractor as per relevant clauses of the contract shall in no way be altered / affected by provision of this Additional Performance Security. - 11) All materials required for the proposed work shall be of specified grade in conformity with relevant code of practice (latest revision) accordingly and shall be procured and supplied by the agency at their own cost including all taxes. If required by the Engineer-in-Charge, further testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their own cost. The agency will arrange the copy of IS Code and give it to the Engineer-in-charge if needed.

Constructional Labour Welfare CESS @1% (one percent) of cost of construction will be deducted from every Bill of the selected agency.

12) **There shall be no provision of Arbitration.**

**No Mobilization advance and secured advance will be allowed.**

Bid shall remain valid for a period not less than 120 (one hundred twenty) days from the last date of submission of Financial Bid / Sealed Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.

**Under any circumstances the successful bidder i.e. the agency will not be allowed to sublet the work to any sub agency / sub-contractor.**

- 13) The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of 01 (one) year from the date of successful completion of the work to the entire satisfaction of the Engineer-in-Charge. If any defect / damage are found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deemed fit. The contractor may quote his rate considering the above aspect.

**Instruction about the work and architect to be associated:-**

14) **Instruction to bidder regarding work and the Architect and the Artist to be associated during execution:**

**All the work and the specifications will be guided by the tender specification, BOQ PWD Schedule or any other similar Govt. Schedule if needed, initial tender drawing (i.e. concept drawing) and subsequent approved drawing and other relevant terms and condition of the tender.**

**The contractor will construct the complete work for construction of 2 storied Tribal Museum made of fibre glass material with necessary art work moulded over MS frame structure at Eco Urban Village and for this work the agency will prepare all necessary working drawings (both Engineering and Art work) based on the initial concept drawing & GAD enclosed with this tender document. The initial plan and the image as enclosed, with this tender, shows only the basic requirement of the proposed Tribal Museum. Based on the initial plan & image (enclosed with this tender document) the successful bidder will have to prepare all necessary engineering drawings by engaging one qualified Engineering Consultant or Architect having at least 07 (seven) years' experience who has complete understanding of Civil & MS Structural work and also glass fibre artistic work. Besides the main frame engineering work there will be a huge quantity of art work for all external elevation surface of the 2 storied Tribal Museum. These art works will be made of pre-moulded fibre glass material as per the approved Art & Design. For making of all necessary pre-mould as per the approved design & art work the agency will engage a competent artist & his team during execution. All the sketch in connection with the art work on fibre glass material and the subsequent relevant moulds must be prepared by qualified and senior artist having at least 20 (twenty) years of experience in professional field of art work in making sculpture, painting, preparing set for film shooting etc. with the help of fibre glass material or similar moulding material including installation work. The Artist should have qualification from any recognized Art College. The agency should submit the BIO-DATA of the artist during online submission of the tender. This will be treated as an eligible criteria along with the work credential for qualifying in to the Bid.**

The agency will produce satisfactory test certificates of all the electrical related devices before its installation at site. Necessary power for its testing will be arranged by the agency. Necessary warranty certificates from the manufacturer will have to be obtained by the agency and such relevant papers will be handed over to the department during completion of the work.

No excuse as regard to want of clarification or any particular point shall be considered after the tender has been received. No advice of any change in rates of condition after that opening of tender shall be entertained.

- 15) **Earnest Money**:-The amount of Earnest Money @2% (two percent) of the quoted amount put to tender in the shape of Bank Draft of any Nationalized Bank drawn in favour of the , **WBHIDCO Ltd. payable at Kolkata** against the work as per this NIT.

- 16) Site of work and necessary drawings may be handed over to the agency phase wise. No claim in this regards will be entertained.

The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all **information's** that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense.

The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The tender accepting authority of WB HIDCO Ltd. reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.

- 17) Prospective applicants are advised also to note carefully the minimum qualification criteria as mentioned in '**Instructions to Bidders**' stated in Section – 'A' before tendering the bids.

**Conditional / Incomplete tender will not be accepted under any circumstances.**

- 18) **The intending tenderers are required to quote the rate online. The rate should be inclusive of all components and taxes.**

**The rate will be quoted in the rate earmarked space of B.O.Q only. Quoted rate will be encrypted in the B.O.Q. under Financial Bid. Rate need not be quoted in WB HIDCO Form of HIDCO.**

- 19) Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.

- 20) Guiding Schedule of Rates: - For any future reference for supplementary items etc. rates will be taken from PWD (WB) Schedule of Rates for "Road & Bridge Works" effective from 1<sup>st</sup> November 2017 and also for "Building Works" and Sanitary & Plumbing Works" effective from of the 1<sup>st</sup> November 2017 along with upto date corrigenda & addend. Public Works Directorate, Government of West Bengal. If rates not available from State Schedules then refer NH Schedule. If not even available in NH Schedule, then market rate analysis may be allowed.

- 21) During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.

- 22) The General Manager-II, WBHIDCO reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.

- 23) If there be any objection regarding prequalifying the Agency that should be lodged on line to the General Manager OR the Tender Evaluation Committee within 04 (four) days from the date of publication of list of qualified agencies and beyond that time schedule no objection will be entertained by the Tender Evaluation Committee.

- 24) Before issuance of the WORK ORDER, the tender inviting authority may verify the credential and other documents of the lowest tenderer if found necessary. After verification if it is found that the documents submitted by the lowest tenderer is either manufactured or false in that case their offer will be treated as cancelled and work order will not be issued in favour of the said Tenderer under any circumstances.

- 25) If any discrepancy arises between two similar clauses on different notification, the clause as stated in later notification will supersede former one in following sequence:

- (1) N. I. T.
- (2) Special Terms & Conditions.
- (3) WB HIDCO Form.
- (4) Bill of Quantities
- (5) Drawings and Images.

- 26) Qualification criteria:

The tender inviting and Accepting Authority through a "Tender Evaluation Committee" will determine the eligibility of each bidder. The bidders shall have to meet all the minimum criteria regarding:

- (a) Financial Capacity [Turnover and Net worth of the bidder]

- (b) Technical Capability comprising of personnel & equipment capability
- (c) Experience / Credential
- (d) Other various points as indicated / mentioned / described above under NIT.

The eligibility of a bidder will be ascertained on the basis of the document(s) in support of the minimum criteria as mentioned in (a), (b) & (c) above and the declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarized. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder / tenderer will be rejected at any stage without any prejudice

- 27) **Escalation of Price on any ground and consequent cost overrun shall not be entertained under any circumstances. Rates should be quoted accordingly.**

### INSTRUCTION TO BIDDERS

#### General guidance for e-Tendering:

Instructions / Guidelines for electronic submission of the tenders have been annexed for assisting the contractors to participate in e-Tendering.

i. Registration of Contractor:

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement System, through logging on to <https://etender.wb.nic.in> (the web portal of WBHIDCO the contractor is to click on the link for e-Tendering site as given on the web portal).

ii. Digital Signature certificate (DSC):

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount. Details are available at the Web Site stated in Clause-A 1 above. DSC is given as a USB e-Token.

iii. The contractor can search & download N.I.T. & Tender Document(s) electronically from computer once he logs on to the website mentioned in Clause-A 1 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

iv. Participation in more than one work:

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job all his applications will be rejected for that job.
