

We would like to request the prospective bidders to verify the IGR value through written communication with IGR instead of checking it online.
2	<b>FAR:</b> You had informed that the FAR will be 4.23 plus additional FAR (Metro & Green) plus 30,000 sq. ft. (for proposed Aquarium) – we shall be grateful if you kindly confirm the calculation to this effect as it will affect the viability and feasibility of the project;	Permissible FAR is 4.2375 in addition to equivalent floor area proposed for aquarium.
3	<b>Ditch:</b> As discussed the "Ditch" is a low land – we shall be grateful if you kindly let us know the recorded status of the "Ditch" and it is not recorded as water body / tank;	Confirmed. It is not recorded as water body / tank.
