# NOTICE INVITING EXPRESSIONS OF INTEREST FOR CONSULTANTANCY WORK FOR DESIGN AND DRAWING OF VELODROME IN AA – IIE IN NEW TOWN, KOLKATA

WBHIDCO hereby invites expression of interest from reputed and experienced Consultants for concept planning, designing, specification and supporting documents, assistance of bid preparation etc. for this project.

**Earnest Money**: Rs. 10,000.00 (Rupees Ten Thousand) only in favour of WB HIDCO Ltd. And Balance amount covering 2% of the quoted amount to be submitted at the time of making agreement by the successful bidder. Scan copy to be uploaded in e-tender portal in pdf format.

Completion Period: Till completion of the project.

## (A) Introduction of New Town, Kolkata:

New Town, Kolkata is one of India's latest and fastest-growing planned new cities. The Township isstrategically situated in the North Eastern Fringes of Kolkata, the capital of West Bengal. On one side, it is adjacent to Salt Lake City, another planned city close to the capital city of Kolkata and on the other, it is in close proximity to the Netaji Subhash Chandra Bose International Airport in Greater Kolkata.

New Town, Kolkata is one of the fastest-growing smart city in West Bengal. WB HIDCO authority has taken up the work of various type of the construction work under the smart city mission project. Velodrome is one of the smart features of the smart city. This velodrome will be constructed in AA-IIE. The velodrome will be an arena of cycle racing.

#### (B) Project Objective:

During covid pandemic period WB HIDCO along with NKDA and smart city has taken a initiative to promote cycling in New Town. In this context Hidco has decided to construct one outdoor cycle velodrome in AA-IIE at New Town, Kolkata.

The aim of the project is to create a facility for the cyclist of New Town and adjacent area to participate in cycling event in global standard velodrome facility.

The velodrome will be an arena of cycle racing. This type of facility is not available anywhere in West Bengal. The length of velodrome will be 250m approx. with on facility of skating in the central open area at Gr. Floor level.

## C) Scope of Work:

Concept, planning for construction of velodrome in AA-IIE, New Town, Kolkata including complete layout & planning for amenities associates and required for the Project approx. length 250M.

- (a) Master Plan of the velodrome.
- (b) Grading & drainage plan for velodrome.
- (c) Cost Estimation of velodrome.
- (d) Structural drawing preparation, submission and vetting from Jadavpur University/IIT or equivalent any Govt. Institution.
- (e) Preparation of Tender documents.
- (f) Construction specifications & supporting documentation for velodrome.
- (g) Assistance in Bid preparation review of tender bids & selection of contractor (if required)

- In absence of any of the above, the bid will be treated as non-responsive and hence shall be rejected.
- B) Bid Evaluation Mechanism:
  - The Bids shall be evaluated through 'Combined Quality and Cost Based Selection (CQCBS)
    process and ranked accordingly by a Committee constituted by WBHIDCO. Both the
    Technical and Financial Bids shall be marked separately;
  - 2) The Technical Bids shall be evaluated based on the following scores:
    - a) General Company Experience in preparation/construction of velodrome of similar type of Work (20 Marks): Out of the 20 marks, 10 marks are allotted for one Project Work and 20 marks for more than one Project Work
    - b) CVs of Key Experts (10 marks);
    - c) Presentation on Methodology, Work Plan and experience profile (40 Marks);
  - 3) Based on their ranking in technical score, the Bidders scoring at least 35 marks out 70 marks will be declared eligible for financial bid evaluation;
  - 4) The Financial Bids of only Technically Qualified Bidders will be opened for further consideration. The Bidder (L1) who has quoted the lowest price will be given a score of 100. The other Bidders (N, N1, N2, N3 etc.) will be allotted scores based on the score of L1 as per the formula: "L1/N x 100". The total score of an eligible Bidder shall be calculated by combining its Technical Score and Financial Score.
  - 5) Based on the total scores of all Qualified Bidders, ranks will be given to them. The First

- Ranked Bidder will be awarded the Consultancy Work.
- 6) The Bidders will have to arrange for Laptops, Computers etc. for their presentation. WBHIDCO will arrange for only venue of the presentation.
- 7) WBHIDCO reserves the right to accept/ reject, at its sole discretion, any or all evaluated Technical/ Financial Proposals of the Bidders and cancel this Bidding process without assigning any reason whatsoever.

#### C) Terms & Conditions:

- The Bidders must have GST Registration Certificates and IT & PAN valid at least up to the date
  of submitting their bids. Applications for such clearance addressed to the competent authority,
  subject to production of authenticated receipt, may also be considered.
- 2) Before submitting any bid / offer, the intending participants should make themselves thoroughly acquainted with the local conditions prevailing by actual inspection of the site, and take into consideration all aspects including actual size and availability of land, communication facilities, climatic conditions, availability of local labourers and market rates prevailing in the locality etc.
  As no claim whatsoever will be entertained on these counts afterwards.
- 3) The selected bidder will have to enter into an agreement with WBHIDCO within 07(seven) days from the date of their Letter of Acceptance (LOA), failing which the award will stand cancelled.
- 4) Any bid /offer containing overwriting is liable to be rejected. All corrections are to be attested under the dated signature of the bidder without which the bid/offer may be informal.
- 5) No conditional bid/offer shall be accepted.
- 6) A prospective Bidder requiring any clarification about the EOI document and scope of work may contact the undersigned through e-mail/ letter before the Pre-Bid Meeting as mentioned below. Their such queries will be discussed in the Pre-Bid Meeting only. No queries from the Bidders will be entertained after the Pre-Bid Meeting. After opening of EOI responses, if the tender committee feels, they may ask for supporting documents in respect of the claim of the bidder and the bidder will have to submit supporting documents as well as written clarifications as required by the committee within three days.
- 7) The EOI response submitted by the Bidder should be in English language only. All the documents relating to the EOI (including brochures) supplied by the Bidder should also be in English, and the correspondence between the Bidder & WB HIDCO will be in English language only

#### D) Bidding Process:

- The Bids will be opened in two stages. Firstly, the Technical Bids will be opened and evaluated. Based on criteria set out, few of the bidders will be shortlisted in the stage-1 bid. In the second stage, only the shortlisted bidders' Financial Bids will be opened.
- 2) The bid documents containing the Company Profile and Work Experience of the bidder will have to be uploaded on the e-portal of NICin .rar file.

- The material for Technical Presentation will have to be submitted both in hard copy and soft copy. The hard copy should be submitted to the undersigned in one sealed cover marked with "Technical Bid for the Consultancy Work for designing & drawing of velodrome in AA-IIE in New Town, Kolkata and duly addressed to the undersigned. The address and contact numbers of the bidder should also be mentioned on the said sealed cover. The soft copy should be uploaded on the e-portal of NICin .rar file.
- 4) The Financial Bid will have to be uploaded on the e-portal of NICin .rar file.
- 5) WBHIDCO Ltd. authority reserves the right to cancel the E.O.I. due to unavoidable circumstances and no claim in this respect will be entertained.
- 6) Bid shall remain valid for a period not less than 120 (one hundred twenty) days from the last date of submission of Financial Bid / Sealed Bid.
