- 4. Retention of security deposit for 3 months for Maintenance work and 12 months for Project work for which provision of clause 17 of 2911 form of WBHIDCO will be superseded.
- **5.** WBHIDCO reserves the right to reject any or all application / Bids at any stage without assigning any reason what so ever to the applicant.

The prospective Tenderer shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and the stipulated defect liability period for the date of successful completion of the work to the entire satisfaction of the Engineer-In-charge. If any defect / damages is found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so penal action against the contractor will be taken as deemed fit. The contractor may quote his rate considering the above aspect.
- 7. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other papers found incorrect/ manufactured / fabricated, the tenderer would not be allowed to participate in the tender and that application will be rejected without any prejudice.
