# NOTICE INVITING QUOTATIONS FROM EMPANELLED TRANSACTION ADVISORS OF GOVERNMENT OF WEST BENGAL

(In cancellation of earlier EOI notice no.C-317/HIDCO/Admn-3587/2019 dated 27.09.2023)

The West Bengal Housing Infrastructure Development Corporation Limited (WBHIDCO), an enterprise under the Urban Development and Municipal Affairs Department, Government of West Bengal, has decided to engage "Consultant & Transaction Advisor" from the empanelled General Transaction Advisors as per Panel A: Physical & Social, as notified by the Finance Department, Government of West Bengal vide their G.O No.190-F(Y) dated 19.01.2022 for computation of Unit cost of saleable WBHIDCO land, Break Even Price of WBHIDCO land along with unit cost of saleable land and suggesting method of accounting to be followed considering the Accounting Standards and Guidance notes issued by the Institute of Chartered Accountants of India and requirements of the Companies Act. 2013. It has therefore been decided to request such empanelled Transaction Advisors to submit offers in the instant matter in terms of the scope of work detailed below within the time frame given herein and as per the parameters fixed for the project.

A pre bid meeting in this connection will be held on 17.10.2023 at 3 pm in the conference hall at HIDCO BHABAN (3<sup>rd</sup> Floor). Attendance in the meeting is not a pre-condition for submission of offers. The response to the pre-bid queries will be mailed to you / uploaded in WBHIDCO's website within 08.11.2023.

offers will be opened on the same day at 4 pm. You may kindly send your representative to remain present during such opening of offers at 4 pm on 22.11.2023. The scope of work is detailed below: -

### A. Scope of Work:

- 1) Analyse the existing income of WBIIIDCO and the revenue centres under WBHIDCO along with the expenditures. All data are to be studied with the help of the different departments and revenue centres of WBHIDCO.
- 2) To assess and compute the total cost of completion of all infrastructure projects including special projects remaining to be done in AA-I, AA-II. AA-III & CBD considering cost already incurred and income which will be generated in the near future.
- To assess the amount of saleable land left to determine BEP (Break Even Price) per cottah of the saleable land.
- 4) To suggest unit land price (per cottah/ per acre) for the remaining saleable land for accounting purpose considering the Total Project Costs and recoverable cost (Cost already incurred minus cost recovered through sale of land plus projected additional costs for the additional project) including mode of recovery in accounts. Data related to land bank will need to be collected from the concerned department of WBHIDCO.
- 5) Computation of unit cost of saleable land per katha along with BEP (Break Even Price) for lands and plots to be sold in near future. The cost of saleable land should be calculated by considering a future plan of 100 years of sustenance of WBHIDCO, considering the existing and projected income / expenditure.
- To assess contingent liability for land acquisition including not verified cases and reference cases.
- To compute actual cost already incurred per cottah of sold / leased out land till 31.08.2023 and to assess operation, maintenance costs including establishment and transport and electricity costs including Parks, Cottages, Halls, Museum, Stadium etc.
- 8) To examine and revise the provision for payment to land loosers.
- Miscellaneous to be decided as per situation, including the audit observations/
   Any other issues as may be considered.

#### B. Proposed Project Timeline:

 Inception Report: Successful bidder to submit an inception report within 30 days from the date of receipt of engagement letter.

- **Draft Report**: Draft report is to be submitted within 45 days of submission of inception report.
- **Final Report**: Final report is to be submitted within 30 days of approval of draft report.

# C. Payment Schedule:

- 15% payment will be made within 15 days on submission of the 'inception report'.
- 40% payment will be made within 15 days from submission of invoice after submission of the 'Draft Report'.
- Balance payment will be made within 21 days from the submission of 'Final Report'.

The intending bidders are requested to submit financial bid after visiting the office and ascertaining for themselves on examination of the records. applicable laws & regulations or any matter as considered relevant by them. The lowest bidder (L-1 bidder) shall be entrusted with to undertake the job.
